### **data protection**

### **Scope of this data protection notice**

Responsible for this privacy notice is the URBANAUTS Hospitality GmbH (hereinafter referred to as "we" or "us") Please read these instructions carefully regarding privacy, the following points are explained in more detail:

- The type of personal information that we collect, stating the purpose
- The transfer of data within our hotel group
- The ability to query your personal information to change or to anonymize.

These instructions are easy to understand as possible. Should you have any questions or individual items you do not understand terms used in full, you can contact us.

### **Personal data that is collected**

If you are interested in our hotel (which included surfing on our website) or book directly with us, you provide us may receive the following data:

- Their personal information such as your address, email address, telephone number and date of birth.
- The personal details of your party
- Payment data (eg credit card data, account information, billing address)
- Your requested / booked services
- travel preferences
- Information about your surfing habits to homepage
- Information on when clicking on one of our acquisitions, including those that appear elsewhere on the Internet
- Information about the way how to visit our website, including operating system, IP address, online identifiers and browser details
- Necessary medical data and any special requirements
- Their preferences in terms of accommodation.
- Your questions / comments / requests in connection with your hotel stay.

### **Other sources of personal data**

We may use personal data from other sources that provide example of companies that provide information and data, trading partners and from public records. If you log in with your access a social network to connect with our platforms and online services such as Facebook, Google+ or Twitter, you

consent to share your user data with us. For example, your name, email address, date of birth, your location and you want to share with us any other information.

### **Personal information about passengers**

We use you submit personal information about other people traveling with you or plan to do so. By submitting personal data about other people, you secure that these agree and may transmit the data. - To conduct market research and internal developments and our range of products, services, stores and IT systems development, security, expertise and methods of our communication with you and improve.
- In order to contact you and interact
- To serve you better as a guest. If you send us we may contact (eg by e-mail, mail, phone, social media and messenger services) use personal information to best-your concern and as quickly as possible to do.

We do not sell your personal information to third parties.

### **Various marketing activities with your consent**

You miss your cancellation by potentially offers that we only represent a special group of guests to available (or similar confirmations) service-related communications are not affected.

We want to ensure that marketing communications (including online advertising) is tailored in connection with our products and services to your interests.

To do this, we use the personal information provided by you or auto-generated to know your concerns better so that we can try to predict to which other products, services and information you might be most interested.

### **Cookies and site analysis**

Cookies are data files that allow a Web site to collect a set of data used on your device and save. Cookies help to provide important features and functionality to our websites. Our permission other companies' cookies may be placed on our websites. For example, we use cookies to do:

### **Sharing data protection relevant data with external service providers**

### **Protecting your personal data**

### **Integration of social media**
